2. purpose to establish and maintain:

b) Maintain/operate and administer schools, colleges, and any other institutions, technical or secular.

3. To establish, maintain or grant aid to homes for the aged, youth, orphanages/children homes, or other establishments for the relief and help to the poor, needy and destitute people, orphans of all ages, widows and aged persons.

4. To take over, acquire, manage, control or aid any existing institution or institutions having objectives either wholly or in part similar to the objectives of the society and on such terms and conditions as may be thought expedient in order to help the poor and needy of all ages.

5. To teach on Hygiene, Environmental Protection, Morality through Lectures, Conferences, Life Seminars, Training Institutions, Literature, Films, TV Programs, and any other appropriate method in order to create awareness among the people in these areas.

6. To establish Moral Centers to teach principles related to such areas as above.

7. To maintain communication and co-operation with other trusts, societies, and individuals within the country as well in other countries for the purpose of promoting directly or indirectly the objectives of the Society in India. In no case, the Society shall extend the benefits to any place outside India.

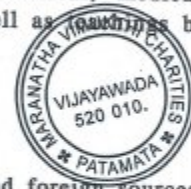
8. To do all such things which are incidental or conducive to the achievement and furtherance of these objectives or any of them.

society is registered under the FCRA act 2010 having a valid license to receive donations from abroad. For domestic donations, the society is exempted under section 80(G) & 12A under IT Act 1961 and all such donations are exempt from the purview of Tax. Except for receiving the donations, this Charity doesn't have any sort of income sources from funding agencies.

Memberships

- Membership of the Society is granted to resident individuals who are committed to live by the moral values and promote the same in the Society and subscribe to the objectives of the Society.
- Each person desirous of admission may have to make an application and such persons whose application is accepted by the Executive Committee shall be admitted as members. The Executive Committee shall decide the total number of members and the admission of the persons to the membership of the Society.

Description of the main activities for the year 2018-2019

Poverty Relief Fund (Children Home) – Providing Food, Education, Clothing, Shelter, Medical, Upkeep and General expenses of Poor, Needy & Orphan Children totaling 135 boys and girls in the home located at Vijayawada. Fifty of them young men and women are in different colleges and universities. We are raising the orphan and poor children irrespective of caste, creed or religion. All of them are from poor, needy, and orphan backgrounds. We meet their educational bursaries like college, school fees, books, dress and other related expenses. We also provide food and shelter to educate them and teach them the moral values of life. We spent totally ₹ 45,75,201 to accomplish the activities.

Women and Destitute Fund – Providing Shelter, Food, Clothing and Medical expenses for widows and destitute. Our support during the year under consideration was for 30 old age people in the shelter situated @ Nunna, Vijayawada Rural Mandal. We normally take those who are abandoned widows, destitute, and those thrown out of their families due to their age and the parents of the children who cannot bear the financial burden of supporting them. Some times when some of the old age people die, no body turns up to do their last rites. With help of youth staying in Youth Training Center situated within the same premises, we conduct the last rites of the deceased. We feel honored serving the old age people in and surrounding areas of Vijayawada in

their situation. We spent totally ₹ 7,00,762 to accomplish the activities.

Medical Support Fund – Supplying of nutritious food and medicines to HIV infected patients numbering 50 people. Monthly support has been providing to differently abled persons. This program is carried on monthly basis. We spent totally ₹ 2,34,693 to accomplish the activities.

Review of the Progress of activities

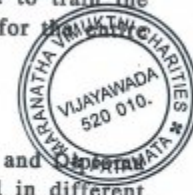
- Providing Educational material (text books) for 135 members.
- Medical support for orphan girls & boys for 135 members @ Vijayawada
- New Year dress gifted to orphan girls & boys for 135 members.
- Apart from the pursuit of the objectives of the Charity, we conducted Counseling classes, motivational talks, meditation, and devotional speeches for the people enlightenment.
- New Year dress donated to 40 members who are elderly widows, widowers & destitute people @ Vijayawada.
- General & cardiac health check-up for 600 members.
- Nutrition food supply for H.I.V./Aids infected people 50 members for every month.
- January- New Year Celebration, a recreational event.
- July -Annual General Meeting
- December- The children's recreation event was held for 3 days. Daily nearly 500 children participated in that event. A special team was invited to train the children on social and ethical values. We spent 50,000 Rupees for the event.

RESULTES ACHIEVED IN THE YEAR 2018-2019

Totally 18 students got passed 10th grade and promoted to Intermediate and courses in the academic year 2018-2019. Four members got graduated in different courses during the academic year.
